**NOTICE OF AGENDA AND PUBLIC HEARING  
FIRST AMENDED AGENDA**

Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the Navigable Stream Adjudication Commission and to the general public that the Navigable Stream Adjudication Commission will hold a meeting open to the public commencing on April 7, 2003 at 9:00 a.m. at the Arizona Department of Transportation Auditorium, 206 S. 17<sup>th</sup> Avenue, Phoenix, Arizona 85007. This meeting may continue on other dates and at times and locations established by the Commission.

Pursuant to A.R.S. § 38-431.03(A)(3), the Navigable Stream Adjudication Commission may vote to go into Executive Session for purposes of obtaining legal advice from the Commission's attorney on any matter listed on the agenda, or pursuant to A.R.S. § 38-431.03(A) or for discussion of records exempt by law from public inspection on any matter listed on the agenda.
